Fiscal Year 2019 Budget Amendment

**REVENUES DECREASED BY \$329,000**

- **Tuition and Fees** - Billing contact hour (BCH) estimates for the year decreased to 117,000 BCH, down 1,150 BCH from original budget. Fees such as, Student Service Fee also decreased as a result of decreased billing contact hours. **Decrease in revenue: \$500,000.**
- **Institutional Scholarships** - A savings realized from unused scholarship awards. **Increase in revenue: \$65,000**
- **Contract Training** - Revenues above budget plan due to increased training activities. **Increase in revenue: \$45,000**
- **Miscellaneous** - Revenues above budget plan due to increased bad debt recoveries. **Increase in revenue: \$42,000**
- **Transfers** - Revenues above budget plan due to a one time transfer from the Foundation. **Increase in revenue: \$19,000**

**EXPENSES DECREASED BY \$329,524**

- **Wages** - Net reduction due to vacant position savings. **Decrease in expense: \$713,990**
- **Retirement** - Net reduction due to vacant position savings. **Decrease in expense: \$309,349**
- **Benefits** - Net reduction due to vacant positions. **Decrease in expense: \$63,600**
- **Services - Staffing Agency** - Net increase. Anticipated increased cost due to increased cost of 7 week course delivery. **Increase in expense: \$249,750**
- **Services** - Adjusted to plan actual for the fiscal year. **Decrease in expense: \$191,582**
- **Materials** - Adjusted to plan actual for the fiscal year. **Increase in expense: \$52,850**
- **Rent, utilities, insurance** - Reduced to projected year end actual. **Decrease in expense: \$222,200**

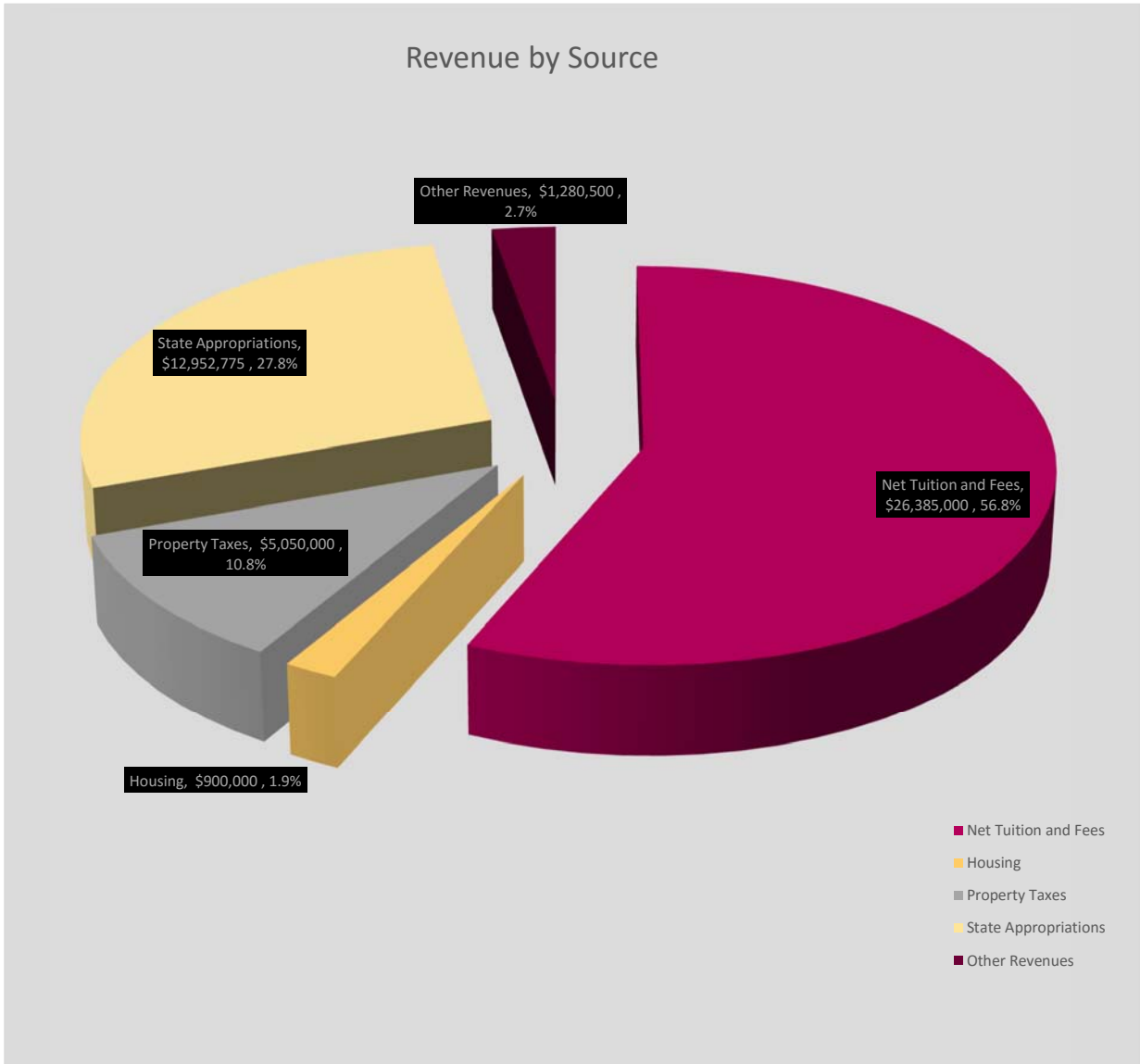
- **Other Operating Costs** - Reduced to projected year end actual. **Decrease in expense: \$536,583**

- **Capital Equipment** - Net reduction. Savings due to holding on computer purchases. **Decrease in expense: \$63,440**

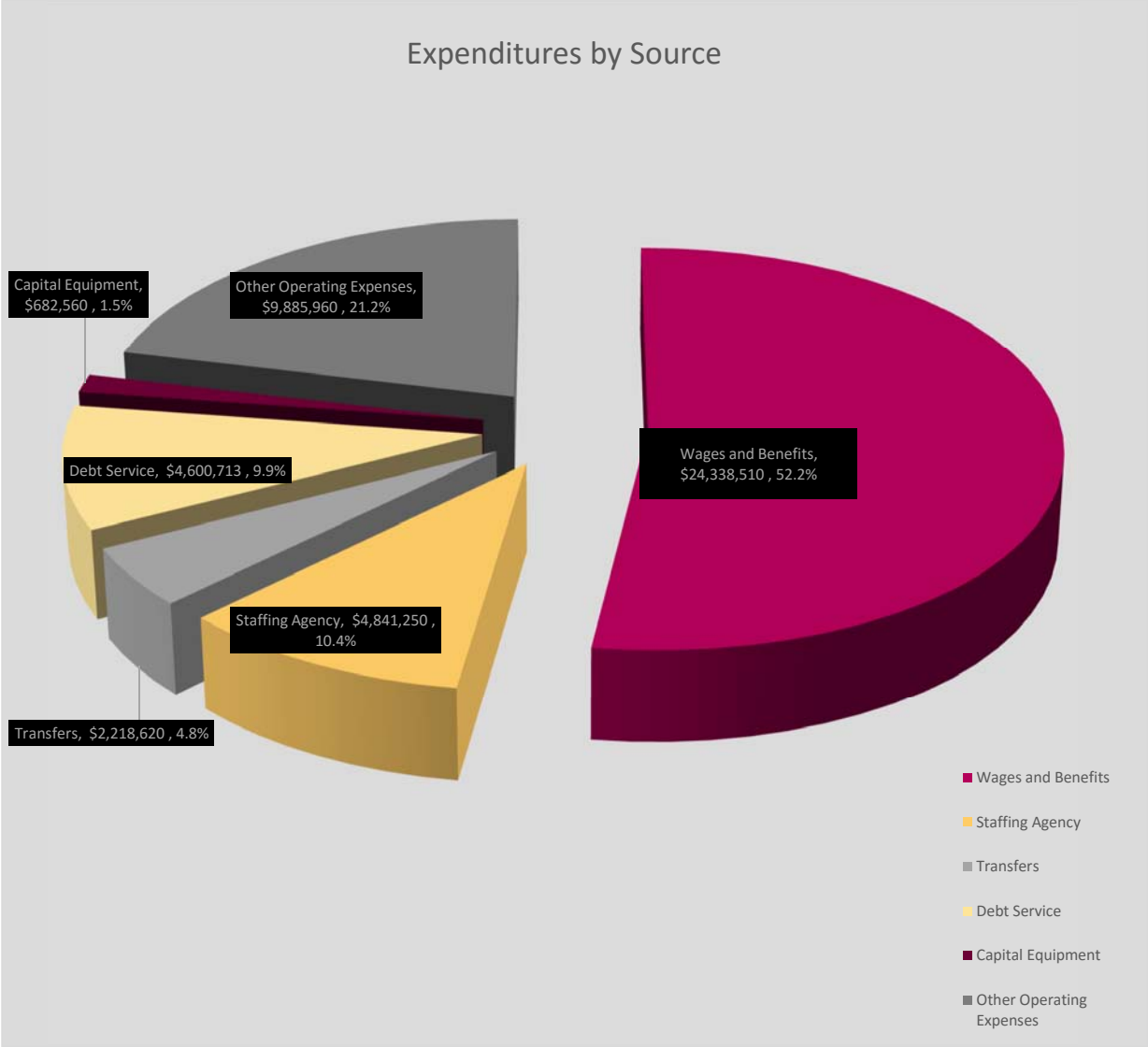
