### **Policy Summary:**

Jackson College strives to provide a learning environment free from the unlawful manufacture, distribution, dispensation, possession, or use of controlled substances. This policy applies to all students (credit and non-credit).

### **Policy Statement:**

Jackson College complies with all applicable Federal, State and local laws including the relevant provisions of the Drug-Free Schools and Communities Act Amendments of 1989. The unlawful possession, use, or distribution of illicit drugs and alcohol by students on Jackson College property or as part of any of its activities is prohibited.

Campus View student housing is an alcohol free living and learning environment. No alcohol is permitted in Campus View regardless of the resident's age.

The Michigan Medical Marijuana Act (Initiated Law 1 of 2008) permits an individual with a qualifying debilitating medical condition to register as a medical marijuana patient with the Michigan Department of Community Health and avoid criminal penalties under state law for certain medical uses of marijuana. Although the use of marijuana for medical purposes is permitted under Michigan law, such use still constitutes a violation of federal law and may result in federal prosecution. Marijuana use may have an adverse impact on future employment, as many employers require drug testing and a conviction can also limit a student's eligibility to obtain federal financial aid. In order to meet its obligations under federal law the College prohibits the possession, use and growth of marijuana on its campus.

Alleged violations of this policy are adjudicated through the Jackson College student judicial process. Consequences for violations may include, but are not limited to, some form of disciplinary probation, required attendance at educational programs, referral for assessment and treatment, relocation to a new living environment, suspension or dismissal from Jackson College as described on the table below. In addition, students may be arrested and fined for violations of federal, state or local laws that occur on campus.
