Advising Details:

Potential GVSU KCON RN-BSN applicants considering the JC/GVSU KCON concurrent enrollment pathway should contact the KCON Office of Student Services (see contact information above).

General Admission Criteria:

The student applies online as a degree-seeking RN-BSN student using the GVSU Office of Admissions Undergraduate application. To determine when to apply, individual students should first meet with a KCON Office of Student Services Advisor.

Admission to the program requires a minimum grade of "C (2.0)" in each pre-requisite course and a minimum GPA of 3.0 overall. Academic performance for the last 15 credits may be considered. Please contact the KCON Office of Student Services with questions regarding how GPA is calculated.

JC AAS-N students admitted to the KCON RN-BSN program will enroll in sessions at GVSU while simultaneously completing the JC AAS-N program. Students will be required to register and pay tuition and fees at each respective institution when concurrently enrolled.

Students will be eligible to continue enrollment in the KCON RN-BSN program upon graduation from the JC AAS-N program and the successful completion of all other KCON RN-BSN program prerequisites including, but not limited to, a cumulative grade point average of 2.0 or higher at graduation from the JC AAS-N program, a grade of 2.0 or higher in each JC AAS required nursing course, and completion of all other prerequisite course work.

As guided by KCON, during enrollment in the senior sequence 400-level nursing courses in the KCON RN-BSN program, the student must complete and maintain comprehensive health compliance obligations. Evidence of active unrestricted RN licensure in Michigan is also required when initiating the senior sequence 400-level courses in the KCON RN-BSN program.

Michigan Transfer Agreement:

Michigan Transfer Agreement/MACRAO satisfies Grand Valley's General Education Foundations, Writing 150, and one Supplemental Writing Skills course. Students transferring with a Michigan Transfer Agreement/MACRAO are still required to complete one SWS course in the major or division as part of GVSU requirements and the Capstone course in that major and the B.A. or B.S. degree requirement where applicable. In the KCON RN-BSN program, NUR 411 is designated as an SWS course. In addition, students must fulfill the two-course Cultures requirement and two (2) Issues courses within the General Education Program. Students should complete a Michigan Transfer Agreement/MACRAO audit at the community college in order to get the Michigan Transfer Agreement/MACRAO STAMP on the official transcript. Students are responsible for ordering/obtaining official transcripts after completing their courses at the community college.

Required Clinical Experiences:

GVSU KCON coordinates NUR 456 precepted practice experiences within the student's geographic area of residence.

Program Cost:

GVSU tuition costs are available on the GVSU Financial Aid Office website at www.gvsu.edu/financialaid/. Additional tuition charges per credit hour for 200 level and above NUR courses for undergraduate students apply. Books, uniforms, transportation, etc. are not included in tuition.
