The Unusual Circumstances Appeal is a formal request students can make to have their dependency status changed from dependent to independent. students requesting a change in financial aid status from dependent to independent.

Documentation may include but is not limited to:

1. A letter (on official letterhead) explaining the situation in detail from an objective third-party such as a social worker, psychologist, high school counselor, teacher, doctor, or other counseling professional.
2. Police reports
3. Court documents

☐ My custodial parent is deceased, and I have had no contact with my living parent (including financial support) for a significant amount of time.

Documentation may include but is not limited to:

1. A copy of the death certificate for the deceased custodial parent.
2. Documentation of the custodial relationship (i.e., student birth certificate, a court document, copy of the divorce decree or other viable evidence that the deceased was the custodial parent).
3. Letter(s) from an objective third party which supports the claim of not having lived with the non-custodial parent (nor received financial support from that parent) for a significant amount of time.

☐ I am a political refugee/eligible non-citizen.

Documentation must include but is not limited to:

1. Immigration and Naturalization Service (INS) documentation verifying the student's status.
2. Other documentation to confirm that the parents are not living in the United States and are unable to provide support.

1. A written explanation that details the situation with your parents.
 - a. Additional documentation will be determined by financial aid.
