Students who would like to request a dependency override to change their dependency status from dependent (requiring contributor information) to independent can do so by completing this Unusual Circumstances Appeal form. Circumstances that may permit a dependency override are explained below.

Check the statement that best describes your current situation. You must submit a **detailed letter explaining your situation** along with acceptable documentation. Please speak with your Financial Aid Specialist for documents required for your situation.

I am unable to be supported by my custodial contributor because of physical abuse, emotional abuse, and/or drug/alcohol abuse. **Documentation** <u>may</u> include but is not limited to:

- 1. A letter (on official letterhead) explaining the situation in detail from a clergy, social worker, psychologist, high school counselor, teacher, doctor, or other counseling professional.
- 2. Police reports
- 3. Other documentation from a social agency
- 4. Court documents

My custodial contributor is deceased and I have had no contact with my living contributor (including financial support) for a significant period of time. **Documentation** <u>may</u> include but is not limited to:

- 1. A copy of the death certificate for the deceased custodial contributor.
- 2. Documentation of the custodial relationship (i.e., student birth certificate, a court document, copy of the divorce decree or other viable evidence that the deceased was the custodial contributor); **and/or**
- 3. Letter(s) from an objective third party which supports the claim of not having lived with the noncustodial contributor (nor received financial support from that contributor) for a significant amount of time.

The student is a political refugee/eligible non-citizen. **Documentation** <u>must</u> include but is not limited to:

- 1. Immigration and Naturalization Service (INS) documentation verifying the student's status.
- 2. Other documentation to confirm that the parents are not living in the United States and are unable to provide support.

1. A written explanation that details the situation with your contributors. Additional documentation will be determined by financial aid.
